The defendant shall submit to one drug test within 15 days of release from imprisonment and at least two periodic drug tests thereafter, not to exceed tests per year, as directed by the probation officer.

- 9) the defendant shall not associate with any persons engaged in criminal activity and shall not associate with any person convicted of a felony, unless granted permission to do so by the probation officer;
- 10) the defendant shall permit a probation officer to visit him or her at any time at home or elsewhere and shall permit confiscation of any contraband observed in plain view of the probation officer;
- 11) the defendant shall notify the probation officer within seventy-two hours of being arrested or questioned by a law enforcement officer;
- 12) the defendant shall not enter into any agreement to act as an informer or a special agent of a law enforcement agency without the permission of the court; and
- 13) as directed by the probation officer, the defendant shall notify third parties of risks that may be occasioned by the defendant's criminal record or personal history or characteristics and shall permit the probation officer to make such notifications and to confirm the defendant's compliance with such notification requirement.

**VIII ADDITIONAL FACTS JUSTIFYING THE SENTENCE IN THIS CASE (If applicable.)**

: disagree with the findings of the Probation Office with respect to the base offense level. The Court agrees with the parties as set forth in ¶ 3(a) of the Plea Agreement that, although the base offense is determined pursuant to U.S.S.G. §§ 2J1.2 (c)(1) and 2X1.3, because the object of the offense was to help two individuals illegally reduce their sentences rather than escape punishment altogether, the starting point of the calculation under U.S.S.G. § 2X3.1 should be the amount of intended illegal sentence reduction, i.e. 54 months, which corresponds to offense level 22 (at CHC III). That yields a base offense level of 16. Adopting the remainder of Probation's recommendations results in a Guideline range of 18-24 months. If the court were to have adopted Probation's findings, the sentence imposed would be below the advisory guideline range by virtue of a binding plea agreement pursuant to Fed. R. Crim. Rule 11 (c) (1) (C).
